ORDER

On October 31, 2008, in Case No. 2008-00032,<sup>1</sup> the Commission approved rates for Burkesville Gas Company, Inc. (“Burkesville”) and provided for their further adjustment on a monthly basis in accordance with Burkesville’s Gas Cost Adjustment (“GCA”) clause.

On July 29, 2010, Burkesville filed its proposed GCA to be effective September 1, 2010.

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

1. Burkesville’s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Burkesville’s proposed Expected Gas Cost (“EGC”) is \$8.5776 per Mcf, which is an increase of \$.2892 per Mcf from the prior EGC of \$8.2884 per Mcf.
3. Burkesville’s notice sets out no Refund Adjustment.

4. Burkesville's notice sets out a current Actual Adjustment ("AA") of (\$.0443) per Mcf. Burkesville's total AA of (\$3.5550) represents a decrease of \$.0443 per Mcf from the previous total AA of (\$3.5107) per Mcf.

5. Burkesville's GCA is \$5.0226 per Mcf, which is an increase of \$.2449 per Mcf from the previous GCA of \$4.7777 per Mcf.

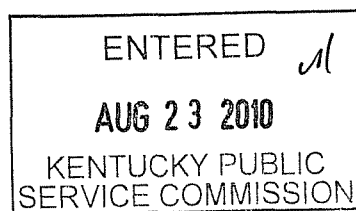
6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Burkesville on and after September 1, 2010.

IT IS THEREFORE ORDERED that:


1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after September 1, 2010.
