
Based on a review of the motion and being otherwise sufficiently advised, the Commission finds good cause to grant the motion and reschedule the hearing.

IT IS THEREFORE ORDERED that:


1. KIUC's motion to reschedule the August 28, 2012 hearing is granted.

5. Any request to cancel or postpone this hearing shall be made by motion filed with the Commission at least one week before the hearing is scheduled to commence.
