ORDER

On June 16, 2011, Kirksville Water Association (“Kirksville”) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Kirksville purchases water from Richmond Utilities (“Richmond”).
2. Richmond notified Kirksville that, effective July 1, 2011, its volumetric wholesale rate to Kirksville would increase from \$2.14 per 100 cubic feet to \$2.17 per 100 cubic feet.
3. Kirksville proposes a purchased water adjustment factor of \$0.05 per 1,000 gallons, to become effective on July 1, 2011.
4. During the 12 months ending April 30, 2011, Kirksville purchased 14,430,538 cubic feet of water from Richmond and sold 93,840,894 gallons of water. The increase in the cost of purchased water is \$4,329.16, resulting in a purchased water adjustment factor of \$0.05 per 1,000 gallons.

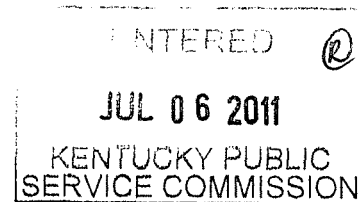

5. The purchased water adjustment factor of \$0.05 per 1,000 gallons is fair, just, and reasonable and should be approved.


IT IS THEREFORE ORDERED that:

1. Kirksville's proposed rates are approved.
2. The purchased water adjustment factor of \$0.05 per 1,000 gallons as calculated in Appendix A is approved.
3. The rates in Appendix B are approved for services rendered on or after July 1, 2011.
4. Within 20 days of the date of this Order, Kirksville shall file revised tariff sheets with this Commission setting forth the rates approved in this Order.
