As further grounds for this motion, Jackson Energy states that much of the information requested by the Commission is not immediately available to Jackson Energy, but can only be obtained from Jackson Energy's wholesale power provider, East Kentucky Power Cooperative, which will require some additional time for Jackson Energy to request and assimilate to meaningfully respond to the requests.
