Dear Mr. Zuger:

The Public Service Commission received from you on December 20, 2011, a public version and a confidential version of the Direct Testimony of Paul Chernick. However, your filing included neither a petition as required by Commission regulation, 807 KAR 5:001, Section 7, requesting confidentiality of the material that was redacted from the public version, nor a cover letter stating that the redacted material had previously been submitted with a request for confidentiality.

If you are filing confidential material that was the subject of a petition for confidentiality previously filed by you or by another party, your filing should include a cover letter which states the following: that the redacted material is subject to a prior petition; the name of the person filing the prior petition; the date the prior petition was filed; and the case number, if the prior petition was filed in a different case. This information will help to avoid confusion in the case file, the inadvertent disclosure of confidential material, and the possible rejection of redacted filings for noncompliance with the above referenced confidentiality regulation.

Accordingly, please file the requisite petition for confidentiality of Mr. Chernick's testimony or a cover letter as described above. Any future filing which contains redacted material should include either a petition or cover letter, as appropriate.
