Frontier Gas Company recently Purchased several small gas Companies here in Floyd and surrounding Counties and combined them into Frontier Gas Co. Each of the Companies were Pricing their gas at different rates before they were bought by Frontier Gas. One example is East Ky. Utilities was Charging me the amount of \$10.23 Per 1,000 cubic feet of gas but a neighboring Company was charging their customers at the rate of \$6.23 per 1,000 cubic feet. Frontier Gas continued with the same pricing after Purchasing these Companies.

Frontier Gas is now asking the PSC to give them permission to raise the rates of pricing on all of their customers for the gas.

Since there is such a great difference in the pricing among the ten companies that Frontier purchased, it seems to me that the only fair and equal thing to do is to equalize the pricing throughout the entire system. This could possibly lower some rates while bringing some rates up to a higher level.

They are also asking for a surcharge of \$1.00 per customer per month to upgrade the meters and a surcharge of \$1.25 per month to replace gas lines. Some of the gas lines are practically new along with the meters. Why should these customers be paying the surcharge since we have already been paying the much higher rate for the gas we have been using? Thanks for your consideration.

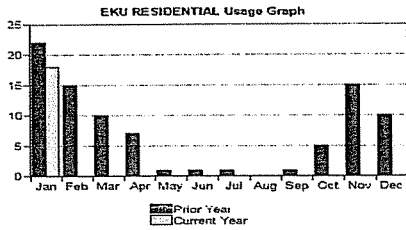
