An Informal Conference (“IC”) was held in this case at the Commission’s offices on February 28, 2012. A list of those participating is shown in Attachment A to this memorandum. The IC had been requested by Commission Staff (“Staff”) for the purpose of discussing information provided by KYTX Oil & Gas, LLC (“KYTX”) in its responses to Staff’s data requests.

The IC attendees discussed when the KYTX system was installed, the customer that had requested service from KYTX, and where on the customer’s property the KYTX well and lines are located. The gas cost component of KYTX’s proposed volumetric rate, specifically the NYMEX 12-month strip on which it was based, was discussed. Finally, the possibility of serving the customer under a special contract was also discussed.
