ORDER

On April 18, 2013, Kentucky Utilities Company and Louisville Gas and Electric Company (collectively "Movants") filed a motion requesting permission to allow Edwin R. Staton, Vice President of State Regulation and Rates, to adopt the pre-filed direct testimony of Lonnie E. Bellar. Movants also request permission for Thomas A. Jessee, Vice President of Transmission, to adopt the pre-filed Direct Testimony of Edwin R. Staton. Movants note that Messrs. Staton and Jessee assumed their new positions, replacing Messrs. Bellar and Staton, respectively, in February 2013.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that Movants have established good cause to permit Mr. Staton to adopt the pre-filed testimony of Mr. Bellar and Mr. Jessee to adopt the pre-filed testimony of Mr. Staton.
