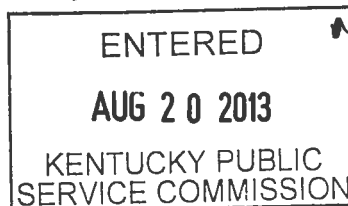
ORDER

On August 19, 2013, Big Rivers Electric Corporation ("Big Rivers") filed a letter, pursuant to KRS 278.190(2), that it intended to place the rates as proposed in its application into effect on August 20, 2013. The Commission finds that its investigation of Big Rivers' proposed rates is not completed and that Big Rivers has complied with the statutory provisions to place its proposed rates into effect.


IT IS THEREFORE ORDERED that:

1. Big Rivers shall maintain its records in such manner as will allow it, the Commission, or any customer to determine the amounts to be refunded and to whom in the event a refund is ordered upon final resolution of this matter.
2. Within 15 days of the date of this Order, Big Rivers shall file its tariffs setting forth the rates it is placing in effect and designating those rates as being subject to change and refund.
