ORDER

On August 6, 2013, the Commission granted Kentucky Cable Telecommunications Association's ("KCTA") Application for Rehearing of the Commission's June 28, 2013 Order denying KCTA's petition for a Declaratory Order. In the August 6, 2013 Order, the Commission stated that it would schedule an informal conference to discuss a procedural schedule for processing the rehearing.

The telephonic informal conference was held on October 3, 2013, where the proposed procedural schedule was discussed. The parties ultimately agreed to the discovery dates that are contained in the Appendix to this Order.

The Commission finds that the proposed discovery dates should be adopted and that a procedural schedule should be issued in this case. Based on the foregoing, IT IS THEREFORE ORDERED that:

1. The procedural schedule set forth in the Appendix to this Order shall be followed in this proceeding.

2. Any party who submits a motion to intervene after October 17, 2013, and upon a showing of good cause, is granted full intervention shall accept and abide by the existing procedural schedule.

3. a. Responses to requests for information shall be filed in accordance with the electronic filing procedures set forth in 807 KAR 5:001, Section 8. Each response shall include the name of the witness responsible for responding to the questions related to the Information provided. Any request for information by letter from the Commission Staff shall be responded to as if set forth in a Commission Order.

b. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or an association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

c. A party shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.

d. For any request to which a party fails or refuses to furnish all or part of the requested information, that party shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

4. Any party filing testimony shall file an original and ten copies with the Commission, with copies to all parties of record.

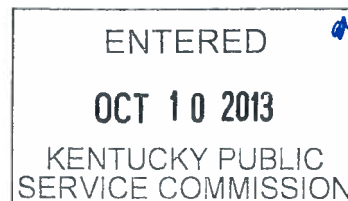
5. At any public hearing in this matter, neither opening statements nor summarization of direct testimony shall be permitted.

6.. Any objections or motions relating to discovery or procedural dates shall be filed within four business days' notice or the filing party shall explain, in writing, why such notice was not possible.

7. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.

8. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
