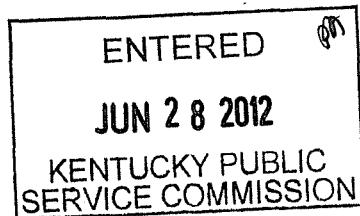
O R D E R

On June 20, 2012, Joe F. 
