Dear Mr. Crockett:

In numerous forums, my staff and I have outlined the risks and issues facing MISO and its stakeholders in regards to the EPA rules being developed and implemented which specifically impact the electric utility sector of the economy. MISO's CEO John Bear has publicly committed that MISO would be resurveying its market participants to expand on the information sought from a 2011 fourth quarter survey. Now that the Mercury and Air Toxics Standards (**MATS**) rule is complete, we are providing you an Excel spreadsheet with questions that specifically address the mechanisms you plan on using to achieve compliance. In an effort to make the survey easy to fill out, we have pre-populated the spreadsheet with your units. If by chance we have missed one of your facilities, please add it to the list and fill in the requested information.

The survey covers the following informational categories:

- 1. Unit name and demographics
- 2. Retire or retrofit status
- 3. Compliance technologies being employed
- 4. Regulatory approvals needed and timing requirements
- 5. Design and procurement information
- 6. Construction beginning and ending dates
- 7. Outage information to install the needed equipment

The intent of the questions is to determine, footprint-wide, if there will be any supply

chain issues, outage issues and resource adequacy issues that will prevent compliance on the schedule laid out by EPA.

We have also included a survey tab in the spreadsheet that addresses the new Reciprocating Internal Combustion Engine **(RICE)** standards that go into effect in May 2013. MISO has a significant amount of Behind-the-Meter generation that may be impacted by the new RICE standards; and, we need to understand the implications of how much of this capacity will not be available to the markets.

I appreciate that you are busy and as such we believe the information that MISO is requesting should be readily available for inclusion in the pre-populated spreadsheet. To further help with filling out the spreadsheet, MISO will be holding a conference call whereby any clarifying questions can be raised and information sought. The date of this call will be February 10, 2012. Additional information for the call will be provided soon. In the interim, if you have any questions please contact John Lawhorn (<u>ilawhorn@misoenergy.org</u>) or JT Smith (<u>itsmith@misoenergy.org</u>). We are requesting the survey information back by March 1, 2012. Please provide your survey responses to JT Smith (<u>itsmith@misoenergy.org</u>).

I want to thank you all for helping MISO and the region develop a thoughtful and coordinate approach this industry changing challenge.
