Subject: TALKING POINTS RE: BREC Proposal # 00300-399

1. We would like your proposal to more specifically establish a specification and estimate the cost for only the replacement equipment for the Wilson Station FGD equipment. This should include necessary equipment starting from the limestone preparation equipment and ending through the dewatering facility. We recognize the scrubber island as the basic replacement criteria however, we want to be sure the limestone preparation facility has the capacity and proper equipment to supply adequate reagent to the scrubber. We also need to be sure that the dewatering facility can handle the scrubber waste product and flow rates.
2. There are other ancillary or balance-of-plant (BOP) systems that will need an engineering review prior to final design but we would prefer these not be part of this scope. We believe BOP systems should not be included in this scope. This includes the following:
 - Scrubber Solid Waste Conversion Facility
 - Solid Waste Transportation and Storage (Landfill)
 - FD/Booster Fan (including Boiler, ESP, ESP, and ductwork pressure study)
 - Auxiliary Power
 - Existing Control Systems
 - Chimney/Liner
 - CEMS
3. This allows the focus of this study to be the FGD Island and FGD Process. We will seek BOP evaluations and cost estimates upon completion of the FGD study/cost assessment.
4. **We would like your opinion on our limiting the scope at this time.**
5. We agree the study should also include a Material/Water Balance study based on the proposed FGD system.
6. What BREC support will you need?
 - Number of people?
 - Hours per day?
7. When could you have a capital cost estimate for the overall project?

8. Performance Guarantees - Should this be included at this time?
