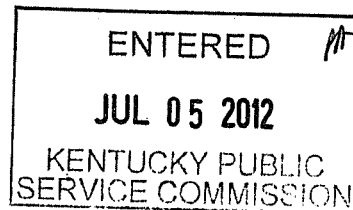

ORDER


The Commission, on its own motion, HEREBY ORDERS that:
