#### ORDER

This matter arises upon the motion of Water Service Corporation of Kentucky (Water Service Kentucky), filed November 5, 2021, for authorization to hold public meetings virtually. The Commission previously ordered Water Service Kentucky to host annual public meetings in the city of Clinton, Kentucky, and the city of Middlesboro, Kentucky, to provide a forum for customers to communicate with utility management. Water Service Kentucky cites public safety concerns related to hosting a local public meeting due to the current uptick in COVID-19 cases across Kentucky.

The Commission finds that such a request is reasonable. However, the Commission cautions Water Service Kentucky to utilize additional means to improve customer communication with its customers, including, but not limited to, bill inserts, social media, and other cost-effective means of communication. The Commission, being otherwise sufficiently advised, finds that Water Service Kentucky's motion should be granted.

1. The motion of Water Service Kentucky to host its December 2021 public meeting virtually is granted.
