Mr. Derouen,

By letter dated March 16, 2012, we were notified that our wholesale supplier, Owensboro Municipal Utilities (OMU) will be decreasing their rate charged to us from \$ 1.65 per 1,000 gallons to \$ 1.60 per 1,000 gallons effective June 1, 2012. As a result, we are submitting a purchased water adjustment to adjust for the reduced water cost to the West Daviess County Water District. Pages 1 and 2 is the information requested by the Public Service Commission for the rate adjustment. Pages 3 and 4 is the revised tariff sheets which pertain to the rate decrease. Exhibit A is the before mentioned letter from OMU. Exhibit B is our calculation of how the decrease will affect the rates to our customers.
