Pursuant to a notice of Informal Conference issued July 19, 2012, an Informal Conference was conducted at the Commission's offices in Frankfort, Kentucky on July 23, 2012. A list of attendees is attached. Clark Energy Cooperative, Inc. ("Clark Energy") and Commission Staff discussed potential settlement in the case and came to an agreement in principle, subject to Commission approval, with regard to the show cause proceeding.

In its response to Item 2.b. of Commission Staff's First Information Request in Case No. 2011-00303, Clark Energy had responded that concerning the Lower Paint Creek project, construction started on 10-03-2011 and was completed on 02-29-2011. Commission Staff requested that a clarification be provided.

Counsel for Clark Energy informed Commission Staff via electronic mail that the correct dates for the Lower Paint Creek project are a construction start date of 10-03-2011 as stated, and a completion date of 11-10-2011.

There being no additional matters to discuss, the conference was adjourned.
