On July 18th, 2012 I received a notice along with my months bill. This notice was to inform me about the annual increase in Revenues of 6.5% and the adjustments of rates and charges that the Kentucky Utilities Company had filed for. This Notice also goes on to say that "Any Corporation Association, Body Politic, or person with a substantial interest to intervene may do say by written Request." So, as a Resident of Kentucky and a consumer Of electricity. This is my request to intervene and strongly **Disagree** with the annual increase and rate changes the K.U is asking for.

As a State employee I have seen my 40 hr. work week reduced down to 37 1/2. We have taken at least 6 mandatory ferlo days, and have been cut back to 30 hrs. a week 4 months in the winter. These hour reductions and cutbacks result in alot less pay. Not only has the Governor cut employees hours he has also talked about cutting back and staying within budget, Then why are we raising rates..???

The K.U already has an Active Rate Increase for school tax on each bill, which is 3% times the bill amount. Plus this New Increase Request they are asking for will cost hundreds of thousands of Kentucky Residents around \$88.92 extra a year. But this amount is based only on homes using 1,000 kilowatt hours, so the estimated

PLEASE TAKE NOTICE that on June 29, 2012, Kentucky Utilities Company ("KU") filed with the Kentucky Public Service Commission ("Commission") a request for an adjustment of its rates and charges to become effective on and after August 1, 2012, subject to the "Stay-Out" Commitment in Article I.1.1 of the Settlement Agreement approved in September 30, 2010 Order in Case No. 2010-00204, under which the change in rates may be filed with the Commission during 2012, but not take effect before January 1, 2013.

The proposed rates reflect a proposed annual increase in revenues of approximately 6.5% to KU.

The estimated amount of the annual change and the average monthly bill to which the proposed electric rates will apply for each electric customer class are as follows:
