CORRECTION TO PETITION FOR FULL INTERVENTION BY LG&E RETAIL RESIDENTIAL CUSTOMER JEFF AUXIER

COMES NOW LG&E retail residential customer Jeff Auxier to correct a mistaken assertion of fact in his August 8, 2012 petition for intervention, and to that end petitioner states:

In the fourth paragraph of Page 2 of his August 8 petition, petitioner stated:

"LG&E now proposes to lower the per kilowatt-hour cost of electricity and raise the monthly flat rate."

That statement errs. In actuality, LG&E proposes to raise the residential monthly basic service charge by 53% and the per kWh price by only 3.74%.

Petitioner's concerns remain the same. The proposed rate change disproportionately raises revenue through the increase in the flat fee. The proposal's fiscal impact on customers such as petitioner who have invested in efficiency and / or contemplate further investment remains significant. The proposal is unfair and bad policy.

Petitioner notes that the presently proposed 53% monthly change follows a 70% increase (from \$5.00 to \$8.50) of the same basic service charge imposed just two years ago.
