O R D E R

On June 20, 2012, Bronston Water Association (“Bronston Water”) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Bronston Water purchases water from Monticello Utility Commission (“Monticello”).
2. On June 15, 2012, Monticello increased its wholesale water rate to Bronston Water from \$2.40 per 1,000 gallons to \$2.60 per 1,000 gallons.
3. On June 15, 2012, Bronston Water increased its rates commensurate with those of Monticello.
4. During the 12 months ending March 31, 2012, Bronston Water purchased 85,976,100 gallons of water, and sold 68,666,310 gallons of water. The increase in the cost of purchased water is \$17,195.22, resulting in a purchased water adjustment of \$0.25 per 1,000 gallons.

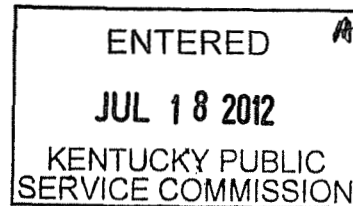
5. The purchased water adjustment of \$0.25 per 1,000 gallons is fair, just, and reasonable and should be approved.

6. Bronston Water's proposed rates are fair, just, and reasonable and should be approved.


IT IS THEREFORE ORDERED that:

1. Bronston Water's proposed rates are approved.
2. The purchased water adjustment of \$0.25 per 1,000 gallons, as calculated in Appendix A, is approved.
3. The rates in Appendix B are approved for service rendered on or after June 15, 2012.
4. The tariff sheets filed by Bronston Water are approved as filed.
