ORDER

On October 31, 2008, in Case No. 2008-00032,<sup>1</sup> the Commission approved rates for Burkesville Gas Company, Inc. ("Burkesville") and provided for their further adjustment on a monthly basis in accordance with Burkesville's Gas Cost Adjustment ("GCA") clause.

On June 28, 2012, Burkesville filed its proposed GCA to be effective August 1, 2012.

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

1. Burkesville's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Burkesville's proposed Expected Gas Cost ("EGC") is \$7.2227 per Mcf, which is a decrease of \$1.1285 per Mcf from the prior EGC of \$8.3512 per Mcf.
3. Burkesville's notice sets out no Refund Adjustment.

4. Burkesville's notice sets out a current Actual Adjustment ("AA") of (\$1.0843) per Mcf. Burkesville's total AA of (\$1.1426) per Mcf represents a decrease of \$.1712 per Mcf from the previous total AA of (\$.9714) per Mcf.

5. Burkesville's GCA is \$6.0801 per Mcf, which is a decrease of \$1.2997 per Mcf from the previous GCA of \$7.3798 per Mcf.

6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for service rendered by Burkesville on and after August 1, 2012.

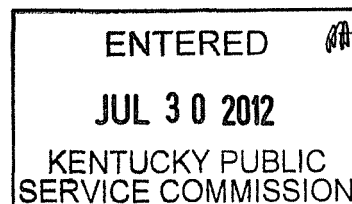
IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are approved for service rendered on and after August 1, 2012.


