ORDER

On July 19, 2012, Reid Village Water District (“Reid Village”) filed its application for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Reid Village purchases water from Mount Sterling Water and Sewer System (“Mount Sterling”).
2. On August 1, 2012, Mount Sterling increased its volumetric wholesale rate to Reid Village from \$2.34 per 1,000 gallons to \$2.41 per 1,000 gallons.
3. Reid Village proposes to apply a purchased water adjustment factor of \$0.08 per 1,000 gallons to its rates.
4. Reid Village proposes to adjust its rates on August 1, 2012.
5. During the 12 months ending May 31, 2012, Reid Village purchased 65,858,810 gallons of water from Mount Sterling. It sold 63,779,211 gallons of water during the same period.
6. The purchased water adjustment factor of \$0.08 per 1,000 gallons is fair, just, and reasonable and should be approved.

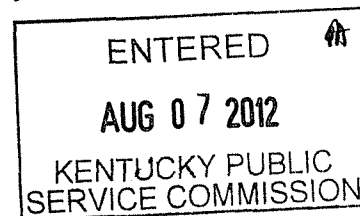

7. The rates set forth in Appendix B to this Order are fair, just, and reasonable and should be approved for water service that Reid Village renders on and after August 1, 2012.


IT IS THEREFORE ORDERED that:

1. Reid Village's proposed rates are approved.
2. The purchased water adjustment factor of \$0.08 per 1,000 gallons, as calculated in Appendix A, is approved.
3. The rates in Appendix B are approved for service rendered on or after August 1, 2012.
4. Reid Village's proposed tariff sheet filed with the application is approved.
