On October 5, 2012, the Commission issued an Order establishing the filed date for Middletown Waste Disposal's above-referenced rate case as October 5, 2012. Pursuant to that Order and 807 KAR 5:076 Section 7(1), Middletown may place its proposed 20% rate increase into effect subject to refund if the Commission has not issued its rate Order within 6 months of the filed date.
