Pursuant to a Commission Staff notice dated January 5, 2011 an informal conference was held at the Commission's offices on January 13, 2011. A list of the attendees is attached hereto. The purpose of the informal conference was to review and discuss the report drafted by the jurisdictional electric utilities in response to the Commission's February 19, 2010 guidance letter concerning smart meter and smart grid.

A representative of Louisville Gas and Electric Company and Kentucky Utilities Company, on behalf of the jurisdictional electric utilities, provided an overview of the draft report. Commission Staff provided comments and asked clarifying questions regarding the certain sections of the draft report. Counsel for the Office of the Attorney General, the Community Action Council, and the gas utilities stated that they will need time to fully review the draft report and will provide their comments to the jurisdictional electric utilities within 30 days. The final draft of the report is expected to be filed by March 31, 2011.

There being no further discussions, the informal conference was adjourned.
