A telephonic informal conference was held at the Commission's offices on October 30, 2012 for the purpose of discussing the procedural aspects of this matter. A list of the attendees is attached hereto.

In light of Kentucky Power's request for an order to be issued on or before December 31, 2012, Commission Staff inquired of the parties whether a formal procedural schedule would be necessary for the processing of this matter. Kentucky Industrial Utility Customers, Inc., an intervenor in this proceeding, advised that it would not be actively participating in this matter but rather would be monitoring the proceedings herein. In light of that response, Commission Staff indicated that the matter would proceed without the need for a procedural schedule.

Commission Staff also asked Kentucky Power when the company would close its books for fiscal year 2012. Kentucky Power roughly indicated that based on the previous fiscal year, it would close its books for fiscal year 2012 sometime between January 10 through January 13, 2013. Kentucky Power would check with its financial auditor and provide a specific date.

There being no further discussions, the informal conference was adjourned.
