Pursuant to Commission Staff's Notice of Telephonic Informal Conference issued May 1, 2013, a telephonic Informal Conference was conducted at the Commission's offices in Frankfort, Kentucky on May 14, 2013 at approximately 11:00 a.m. A list of attendees is attached.

Commission Staff asked a number of questions concerning the Joint Applicants' proposed retrofit permanent program. Commission Staff requested that joint applicants submit the following information concerning the current retrofit pilot program: 1) the number of participants, per cooperative, that are enrolled in the program; 2) the number of program participant premises, per cooperative, that currently have inactive accounts; and 3) the total amount of program investments, per cooperative, made by the Mountain Association for Community Economic Development ("MACED"). This information will be submitted by May 21.
