SUBJECT: December 12, 2012 Informal Conference

A telephonic Informal Conference (“IC”) was held in this case on December 12, 2012 at the Commission’s offices. Participants included representatives of Big Rivers Electric Corporation (“Big Rivers”), Alcan Primary Products Corp., Kentucky Industrial Utility Customers, Inc. (“Intervenors”) and Commission Staff. The attendance list for the IC is enclosed with this memorandum. The purpose of the IC was to ascertain the extent of the Intervenors’ interest in this case and determine whether discovery on Big Rivers’ application would be necessary.

The Intervenors indicated that their level of interest was sufficient to determine that a procedural schedule should be prepared to allow for one round of discovery by the Intervenors. It was agreed that the schedule would include the opportunity for the Intervenors to file written comments on Big Rivers’ application and permit Big Rivers the opportunity to file reply comments. The schedule agreed upon would also provide the opportunity for any party to request a formal hearing before the Commission.

There being no further issues to discuss, the conference was adjourned.
