On May 28, 2013, the Commission held a public hearing at Bryant Station High School, 201 Eastin Road, Lexington, Kentucky, to take public comment on Kentucky-American Water Company's ("KAWC") proposed rate adjustment. Commissioners David Armstrong, James Gardner, and Linda K. Breathitt were present. At the request of Chairman Armstrong, Vice Chairman Gardner presided.

Commissioner Gardner called the hearing to order at 6:20 p.m. He recognized Commission Staff members and counsel for the parties who were present. (A listing of all members of the public present at the hearing is set forth in Attachment 1.) He set forth the purpose for the hearing and the procedure that would be followed.

At 6:26 p.m. Lexington-Fayette Urban County Mayor Jim Gray spoke in opposition to the proposed rate adjustment. He stated that KAWC was attempting to force the citizens of Lexington to pay for KAWC's poor business decisions. He stated that KAWC, by choosing to construct the Kentucky River Station II plant, had made a poor business decision. He stated that, in light of increased water conservation and falling industrial customer demand, the water treatment facility was not needed and that KAWC now suffered from excess capacity. To eliminate this unneeded capacity, furthermore, KAWC was now acquiring smaller water systems, such as Owenton. He further criticized KAWC's refusal to continue billing for Lexington-Fayette Urban County Government's ("LFUCG") sewer and storm water services. He stated that KAWC's refusal had cost the citizens of Lexington approximately \$3.2 million. Mayor Gray urged the Commission to reject the proposed rate adjustment.

At 6:33 p.m. Mr. Don Pratt stated his opposition to the proposed adjustment. He stated that the proposed increase is the result of the construction of an unneeded water treatment plant and would hurt lower income persons. He urged the Commission to reject the proposed increase.

At 6:38 p.m. Mr. Ray Link expressed concern about KAWC's refusal to bill for LFUCG's sewer and storm water services. He urged the Commission, if it found that

KAWC had lost revenue as a result of its decision, to impute that forsaken revenue to KAWC when determining KAWC's rates.

At 6:39 p.m. Douglas Slaughter asked whether KAWC's application was available on the Commission's website. After being advised that it was, Mr. Slaughter urged the Commission to deny the requested riders for distribution main replacement and chemical/purchased power. He stated that the proposed riders represented a threat to the Commission's ratemaking authority.

As no other speakers appeared, Commissioner Gardner closed the hearing at 6:42 p.m.


