1. JPEC’s address is 2900 Irvin Cobb Drive, Paducah, Kentucky 42002. JPEC’s mailing address is P.O. Box 3188, Paducah, Kentucky 42002-3188.

2. JPEC is a distribution cooperative and a member of Big Rivers Electric Corporation (“Big Rivers”), the applicant in this proceeding. As a member of Big Rivers, JPEC has an interest in this proceeding because it will be directly affected by the Commission’s rulings and orders herein. The outcome of this case will affect JPEC’s members, tariffs and relationship with Big Rivers.

3. JPEC should be permitted to intervene because its interest is not otherwise adequately represented by any other party. Further, JPEC’s intervention will likely present


