

ORDER

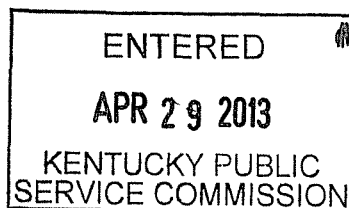
The Commission, upon its own motion, HEREBY ORDERS that:
