On April 16, 2015, Commission Staff, representatives from Kentucky Cable Telecommunications Association ("KCTA"), and representatives from Hickman-Fulton Counties Rural Electric Cooperative Corporation, Pennyrile Rural Electric Cooperative Corporation, Tri-County Electric Membership Corporation, Warren Rural Electric Cooperative Corporation, and West Kentucky Rural Electric Cooperative Corporation (collectively "TVA Cooperatives") participated in a telephonic informal conference. A copy of the sign-in sheet of those who participated is attached.

The purpose of the informal conference was to discuss the future procedure following KCTA's filing of a Motion for Summary Judgment. Counsel for the TVA Cooperative stated that more time was needed to respond to the Motion for Summary Judgment than the standard 7 days times. Counsel for KCTA stated that if the TVA Cooperatives received additional time to respond, KCTA should have an equivalent amount of time in which to file a reply. Commission Staff suggested that the parties file a joint motion for a procedural schedule. Commission Staff also stated to KCTA that the depositions of the TVA Cooperatives representatives should be filed with the Commission. The parties agreed to file a joint motion for a procedural schedule and KCTA agreed to file the depositions with the Commission.
