ORDER

On April 13, 2015, the Kentucky Cable Telecommunications Association ("KCTA") filed a motion for Summary Judgment with the Commission. On April 16, 2015, Commission Staff, representatives from Hickman-Fulton Counties Rural Electric Cooperative Corporation, Pennyrile Rural Electric Cooperative Corporation, Tri-County Electric Membership Corporation, Warren Rural Electric Cooperative Corporation, and West Kentucky Rural Electric Cooperative Corporation (collectively "TVA Cooperatives"), and representatives from KCTA participated in an informal conference to address procedural issues in responding to the motion for Summary Judgment. On April 17, 2015, as a result of the informal conference, the parties filed a joint motion for a procedural schedule, agreeing to the filing dates that are contained in the Appendix to this Order.

The Commission finds that the proposed filing dates should be adopted and that a procedural schedule should be issued in this case.

IT IS THEREFORE ORDERED that:

- 1. The procedural scheduled set forth in the Appendix to this Order shall be followed in this proceeding.
- 2. No representative of the TVA Cooperatives or their counsel will take any action regarding (including any review of) KCTA's pending motion for Summary Judgment until after the TVA Cooperatives' motion for Summary Judgment is filed on May 12, 2015.
- 3. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.
- 4. Nothing contained herein shall prevent the Commission from entering further Orders.
