

13 Comes Big Rivers Electric Corporation (“Big Rivers”), by counsel, and moves

14 pursuant to 807 KAR 5:001§5 that the Public Service Commission (“Commission”)
15 set the principal hearing in this case during the first week of December of 2013. In
16 support of its motion, Big Rivers states as follows:


17 1. The procedural order of the Commission in this matter dated July 18,
18 2013, shows the last scheduled event being the filing by Big Rivers of rebuttal
19 testimony on November 20, 2013, with the date for the hearing left to be scheduled
20 later.

21 2. Big Rivers’ witness Daniel M. Walker, who has prefiled testimony in
22 this case under Big Rivers’ Application Tab 65, will be unavailable and out of the
23 country from December 8, 2013, through December 22, 2013, on a long-planned trip.
24 Mr. Walker is an important witness in Big Rivers’ case on the subject of the TIER
25 required for Big Rivers to begin the process of regaining investment-grade credit
26 ratings.

1 For these reasons, Big Rivers respectfully requests that the hearing in this
2 case be scheduled for days certain during the period of December 2 through 6, 2013,
3 to allow Mr. Walker to be present on behalf of Big Rivers.


