- (3) 807 KAR 5:001, Section 16(2)(c) Has a copy of the notice of intent, in a portable document format, been served upon the Attorney General by electronic mail. The cover letter to application indicates a cc: to Attorney General at a physical mailing address, not an electronic copy mailed. If Jackson Energy has electronically transmitted a copy of the Application to the Attorney General, ("AG") please submit proof of transmission. If an electronic copy of its Application to the AG, Jackson Energy should send an electronic copy of its Application to the AG and provide proof of transmission.

- (4) 807 KAR 5:001, Section 16(1)(b)(4) New or revised tariff sheets, if applicable, in form complying with 807 KAR 5:011 with an effective date not less than thirty (30) days from the date the application is filed. Jackson Energy's 6th Revised Sheet No. 8 contains an effective date of September 15, 2013. The remainder of Jackson Energy's tariffs contain an effective date of September 20, 2013. Jackson Energy's Application states at paragraph 1 that Jackson proposed to adjust rates effective September 15, 2013. Jackson Energy's tariffs must contain an appropriate signature. If an electronic signature is used, the appropriate symbol: "/s/" followed by the officer's name must appear.
- (5) 807 KAR 5:001, Section 16(4)(a) Public notice must include the present and proposed rates for each customer class to which the proposed rates with apply. At Exhibit D, Page 3 of 4, the Present rate listed for the 35 ft. Aluminum Pole for Cobra Head is incorrect. The correct figure should be \$27.24 instead of \$22.24.

The statutory time period in which the Commission must process this case will not commence until the above-mentioned required information is filed with the Commission. You are requested to file this information within 10 days of the date of this letter.
