This email is to summarize the telephone conference and communications occurring shortly after the conference.

During the telephone conference earlier today, Todd Osterloh, attorney for Water Service Corporation, agreed to circulate a nondisclosure agreement to Sue Ellen Morris, attorney for Hickman County Fiscal Court, and Jennifer Hans, attorney with the Attorney General's office.

Todd will research why the spreadsheets on the cd and what has been filed electronically do not contain all the necessary information. After the conference, Todd advised that links imbedded in the spreadsheet are links to internal documents within Water Service Corporation. These links cannot be accessed outside of Water Service Corporation's computer system. Todd is researching how the requested information can be provided to the Commission and parties.

Todd agreed to provide to Sue Ellen and Jennifer, a cd containing the same information provided to the Commission. Shortly after the telephone conference, Todd provided documents via email and indicated that he would send a cd if a cd was preferred.

Todd indicated that he had not electronically filed documents in an excel format because the regulation indicated that electronic files must be in pdf format. We discussed that excel files can be imbedded in versions 10 and 11 of adobe acrobat. 807 KAR 5:001 Section 8 does indicate that electronic files are to be in pdf format, although the electronic filing system does accept files in excel format.

Todd was advised that using a separate electronic file for each response to a data request makes viewing the responses more difficult.

Sue Ellen and Jennifer agreed that Todd could discuss with Commission staff the technical issue of providing the requested information. Sue Ellen and Jennifer will be notified of the conversations but will not be included in the conversations.
