I am sorry to see the Louisville Gas and Electric Co has petitioned to raise the fixed monthly electric and gas meter fee. This will imposed a hardship for small users as well as low-income users. This fee increase proposal will also have a negative effect on those wishing to install alternative electric power as the monthly increased fee takes away much of the cost savings from installing alternative power. This seems like an easy way for the utility company to gouge users with a back door fee and this is totally unnecessary. We are paying for gas and electricity not meters. There should be no reason to increase the monthly meter fee. Actually, I believe customers should be offered the opportunity to buy the meter and not be charged any monthly fee.
