## ORDER

On June 18, 2014, Louisville Gas and Electric Company and Kentucky Utilities Company ("LG&E/KU") jointly filed a Motion to modify the existing procedural schedule in this case and to amend their June 12, 2014 Motion for an informal conference. Specifically, LG&E/KU request that the deadline to request an evidentiary hearing be extended to July 7, 2014, and that their June 12, 2014 Motion for an informal conference on June 19, 2014 be amended to be held on June 30, 2014. There are no objections to the motion.

As grounds for their motion, LG&E/KU state that an informal conference to discuss the need for a formal hearing would benefit all parties because it might avoid the need to file a request for a formal hearing. LG&E/KU note that they filed their rebuttal testimony on June 16, 2014, and that Sierra Club objected to a June 19, 2014 informal conference asserting that there was inadequate time to review LG&E/KU's rebuttal testimony. LG&E/KU requests that, in order to allow ample time to review the

rebuttal testimony, the informal conference be scheduled for June 30, 2014 and the deadline for requesting a public hearing be extended to July 7, 2014.

The Commission finds that good cause exists to grant LG&E/KU's Motion.

IT IS THEREFORE ORDERED that:

- 1. Parties shall file a request for an evidentiary hearing no later than July 7, 2014.
- 2. An informal conference shall be held on Monday, June 30, 2014, at 11:00 a.m. Eastern Daylight Time, in Conference Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, for the purpose of discussing the issues in this case. Commission Staff will contact all participants by electronic mail to provide the details for joining the conference via conference call.
