ORDER

On February 23, 2015, the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention ("AG"), filed a motion requesting a limited extension of time to file supplemental requests for information to Kentucky Power Company ("Kentucky Power") relating to the AG's Initial Data Request, Item Nos. AG 1-62, 1-85, 1-143, 1-147, 1-148, and 1-170. The AG states that his supplemental data requests related to all other items will be filed by February 24, 2015, pursuant to the existing procedural schedule, but that an extension until February 27, 2015, is needed due to Kentucky Power's objection to filing certain documents requested in the AG's Initial Data Request and making them available for inspection only in Kentucky Power's offices. Further, the AG's motion states that Kentucky Power has no objection to this motion.

The Commission, having considered the AG's motion and finding good cause, HEREBY ORDERS that the AG's motion for an extension of time until February 27,

2015, to file supplemental requests for information relating to the AG's Initial Data Requests, Items AG 1-62, 1-85, 1-143, 1-147, 1-148, and 1-170, is granted.
