ORDER

On February 5, 2015, the Commission issued an Order initiating this proceeding to review Kentucky Power Company's ("Kentucky Power") fuel adjustment clause for the two-year period from November 1, 2012, through October 31, 2014. On February 6, 2015, Kentucky Power filed a motion to amend the procedural schedule established by the February 5, 2015 Order. On February 11, 2015, the Commission granted Kentucky Power's request and issued a revised procedural schedule. On February 27, 2015, the Kentucky Industrial Utility Customers, Inc. ("KIUC") filed a Motion to Amend Procedural Schedule ("Motion") requesting that the procedural schedule be amended further by establishing a deadline of April 8, 2015, for intervenor testimony. KIUC states that the filing of intervenor testimony is likely to assist the Commission in the development of a more comprehensive record.

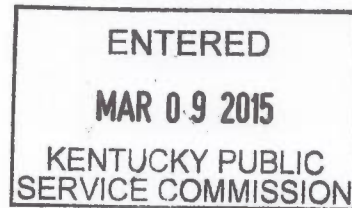
On March 3, 2015, Kentucky Power filed a response to KIUC's motion, arguing that it should be allowed an opportunity to file rebuttal testimony if the Commission were to grant KIUC's motion.

Having reviewed the evidence and being otherwise sufficiently advised, the Commission finds that KIUC has presented good cause to amend the procedural schedule to allow for the filing of intervenor testimony. The Commission will also amend the procedural schedule to allow for discovery on intervenor testimony and the filing of rebuttal testimony by Kentucky Power. The inclusion of additional steps in the procedural schedule will require the rescheduling of the hearing in this matter, which had been set for April 7, 2015. Therefore, the Commission finds that all parties should adhere to the procedural schedule attached as an appendix to this Order.

IT IS HEREBY ORDERED that:

1. KIUC's motion to amend the procedural schedule is granted.
2. All parties shall adhere to the procedural schedule set forth in the Appendix to this Order.
3. All other provisions of the Commission's February 5, 2015 Order shall remain in full force and effect.
