SUPPLEMENTAL MOTION OF BLUE GRASS ENERGY COOPERATIVE CORPORATION FOR CONFIDENTIAL TREATMENT OF MATERIAL UNDER 807 KAR 5:001 SECTION 13 AND KRS 61.878

Blue Grass Energy Cooperative Corporation ("BGE") moves the Kentucky Public Service Commission pursuant to 807 KAR 5:001, Section 13 and KRS 61.878 to grant confidential protection for material provided in movant's responses to Question 8 of Attorney General's "Clarification Questions on the Supplemental Responses" which applies to Item 27 of "Response of Attorney General Second Request for Information" (AG Item 27). BGE has a pending Motion for Confidential Treatment Responses to AG Item 27.

SPECIFIC GROUNDS PURSUANT TO KRS 61.878 FOR CLASSIFICATION OF MATERIAL AS CONFIDENTIAL

BGE adopts and incorporates by reference herein the specific grounds for confidentiality protection based upon KRS 61.878(1)(a) (unwarranted invasion of personal privacy) and KRS 61.878(1)(c)(1) (generally recognized as confidential permitting unfair commercial advantage to competitors) and the supporting discussion and legal arguments supporting confidential treatment of responses to AG Item 27. This Motion for Confidentiality applies to the BGE response to Question 8 of the AG's "Clarification Questions on the Supplemental Responses" in reference to AG Item 27.

CONCLUSION

1. BGE requests confidential treatment of all response material for AG Clarification Question 8 related to AG Item 27 as set forth above.

Blue Grass Energy Clarification Questions on the Supplemental Responses

- Please reference the Company's response to AG 2-1. Provide full details as requested, as to the specific nature of employee no. 110 receiving pay raises of 3%, 16.4%, 21.2%, 6%, 8.5%, and 8.7% for the years of 2009-2014, and for employee no. 2539 with a 59.7% raise, 2.3%, 2.6% and 6.5% for years 2011-2014.
- Please reference the Company's response to AG 2-2. Provide full details as requested as to the specific nature of the President/CEO receiving a raise of 21.2% in 2011, 6% in 2012, and 8.5% in 2013 which resulted in almost a \$100,000 raise in salary in only two years since the effective dates were form 2/28/11 and 3/2/13.
- 3. Please reference the Company's response to AG 2-6. The Company responded that there are no minutes detailing the Board of Directors discussing rates, other than what has been provided. BGE has only provided that Jane Smith moved to approve the resolution stating the intent to file for a rate increase, etc. Are detailed or general BOD minutes not taken? Reference AG 2-8, where the Company states, "[w]e have been discussing the need for a rate design change with the board for several years during our financial reviews." Please provide the board of directors meeting minutes for every BOD meeting between January 2008 and September 2014 where rates were discussed.
- 4. Please reference the Company's response to AG 2-13. Is any of the customer charge increase attributed to the revenue increase of \$2,452,901 or is that separate from the revenue increase? Please advise how much additional revenue the increased customer charge will provide the Company, when compared to the existing revenue received from the customer charge.
- 5. Please reference the Company's response to AG 2-14. Clarify what the response of (55,617) indicates. Does it mean that the interest expense adjustment would only be reduced by \$55,617? Please explain in full detail this response.
- 6. Please reference AG 2-21. Provide what the interest expense is if BGE used the normal approach and used actual interest rates of loans versus the interest expense using higher interest rates than what are currently paid. Provide both figures and designate which is actual versus adjusted.
- 7. Please reference AG 2-22. Explain how the first step maintenance increases would affect bills starting with June 1, 2014, even though that would be last year's bills? Then explain how the second step rate increase would take effect this summer on June 1, 2015? Please confirm that BGE did not mean to state that the first step would be implemented June 1, 2015, and the second step June 1, 2016?

- 8. Please reference the Confidential Company response to Ag 2-27. Please advise why 2009 is not available. Also, please provide the Company's policy and procedure on awarding Christmas and Regular bonuses. For example, how does the Company choose who receives Christmas/Regular bonuses, are the bonuses given to everyone, how is the amount of bonus determined, etc.
 - a. Are the Christmas and Regular bonuses removed in the application to increase rates for ratemaking purposes?
