Jim,

It has been awhile since I've seen you, Michelle or Will. I hope all is well.

Given your role, I wanted to share with you that I'm concerned about the KU case before the Kentucky Public Service Commission (PSC) (2014-000371).

Shifting more of KU's fixed costs to its meter or "customer fees"—the monthly sums all customers must pay, no matter how much power we use—would hurt low-income households and strip some of the financial rewards otherwise reaped by customers who install energy-saving equipment or solar panels.

KU's fixed costs haven't grown by 67%. From what I have read, utilities in all 50 states have recognized that the growing customer interest in energy efficiency and renewable energy has begun

eating into their profits and are trying to restructure their rates to protect those profits.

After all, \$18 every month before ever turning on a light or an air conditioner, in addition to paying higher rates for every kilowatt-hour of power they use, is a healthy family dinner or a prescription co-pay.

Like many Lexington homeowners, Jake and I have been investing in the energy efficiency of our home to make it more comfortable, lower our bills and be more ecologically sound. Now that Delaney is graduating from college, we've begun considering adding solar panels to our roof. As long as these investments reduce air pollution, improve the health of everyone in our region and create jobs, it would be a real disservice to cut into the returns on these investments.

Lexington already has some of the worst air among the 100 largest US cities, according to the Brookings Institute, chiefly due to our power plants. When the new EPA rules go into effect, KU will have to find ways to cut its carbon pollution by 18%. Energy efficiency and renewable energy sources are its cheapest, cleanest and fastest options for complying. I think the last thing the PSC should do is allow rate restructuring that would undercut the business case for them.

I oppose the fixed meter rate increase to \$18.00/mo in the referenced case. Although a total ROI of over 10% seems excessive to me, I am not objecting to this total, only in increasing the fixed charges relative to the per KW charge. I would much rather have a larger per KW, variable charge, than the current proposal. I have not seen justification for why the proposed distribution for fixed and variable charges. A larger proportion of variable charges would encourage conservation, alternate energy generation, and provide for more control of energy costs by the user. To be clear:

- 1) the total proposed rate increase giving a total revenue increase of \$153MM is ok
- 2) the fixed meter charge increase to \$18.00/mo is being objected to
- 3) a better solution would leave the meter charge at its current level of \$10.75 and then provide for the requested revenue increase through an appropriate per-KW rate increase.

To whom it may concern:

Kentucky has the opportunity, right now, to transform our energy systems and economy by embracing low-cost clean energy solutions including energy efficiency and renewable energy. Diversifying our energy sources and becoming more energy efficient is the right approach for our health and climate. It is also in the best interests of Kentucky's ratepayers.

The current proposals disproportionately and inequitably increase bills for the smallest residential customers who take steps to keep their energy use low. This group includes many individuals who have low or fixed incomes and pay a high percentage of their monthly income for home energy costs. Under these proposals, low-energy users would subsidize customers who have larger homes and/or higher energy use.

Encouraging energy efficiency should be a high priority for the Kentucky Public Service Commission and utilities operating in Kentucky. It far less expensive for utilities and their customers to invest in energy efficiency than to build out new generation and transmission infrastructure. Kentucky's rate structures and policies should encourage, not discourage, private investments in energy efficiency and distributed renewables.

Unfortunately, the current rash of utility rate cases before the PSC (Case No. 2014-00371) would have the opposite effect. These proposals actually discourage energy conservation and distributed renewable energy generation. In fact, experts who examined the LG&E case determined that the new rate structure would actually cause customers to increase their energy consumption by 2% over several years. A similar impact could be expected in similar cases involving Kentucky Utilities, Kentucky Power, and Bluegrass Energy. This is due to the fact that customers would benefit less from reducing their energy consumption under the proposed rates.

These rate proposals will also restrict the growth of Kentucky's clean energy economy, including jobs in the solar and energy efficiency industries, at a time when those sectors are booming in other states. Kentucky's Public Service Commission should not allow utilities to crowd out private investment in energy efficiency and renewable energy by rigging their rate structures to their own distinct advantage.

I strongly encourage the PSC to disapprove KUs request for rate restructuring in case 2014-00371. This is an attempt to protect their profits in a way that is unjust to customers who have no other choices for filling their electricity needs. It will also harm efforts to increase energy sustainability.

I encourage the commission to consider the long term consequences of shifting more electricity costs to fixed. Customers should pay based on their usage. Customers who use more should pay more. Those customers who try to use energy efficient measures should not be punished.
