On June 1, 2015, Commission Staff held a telephonic informal conference ("IC") with Big Rivers Electric Corporation ("Big Rivers"), the Attorney General of the Commonwealth of Kentucky ("AG") and the Kentucky Industrial Utility Customers, Inc. ("KIUC"). KIUC contacted Commission counsel via e-mail and requested the IC to discuss procedural issues for the June 2, 2015 hearing. A copy of the e-mail is attached hereto. Commission Staff in attendance were Quang Nguyen, Matthew Baer, and Chris Whelan. Participating by phone were Jennifer Hans for the AG; Tyson Kamuf for Big Rivers; and Mike Kurtz, Kurt Boehm, and Jody Cohn for KIUC.

The parties discussed procedural aspects of the June 2, 2015 hearing. Jennifer Hans stated that she would be present at the hearing for the AG. Mike Kurtz stated that Kurt Boehm would represent KIUC at the hearing. Since Mr. Kurtz, and not Mr. Boehm, was a signatory to the stipulation, Mr. Boehm will submit a signature page and take the oath administered at the hearing with regard to the stipulation. There being nothing further to discuss, the meeting was adjourned.
