ORDER

On June 12, 2015, the Commission issued an Order for the six-month review of Louisville Gas & Electric Company's ("LG&E") environmental surcharge for the billing periods ending April 30, 2014, and October 31, 2014. Having discovered errors in the Commission's June 12, 2015 Order, the Commission, on its own motion, finds that: (1) in the first full paragraph on page 2, the number \$326,422 should be amended to \$326,442; and (2) on page 5, ordering paragraph 2 should be amended to require a decrease in LG&E's jurisdictional environmental revenue requirement for one month instead of the stated two months.

IT IS THEREFORE ORDERED, *nunc pro tunc*, that:

1. The reference to \$326,422 on page 2 under the heading Surcharge Adjustment to the Commission's June 12, 2015 Order is amended to read \$326,442.
2. Ordering paragraph 2 to the Commission's June 12, 2015 Order is amended to read:

In the second full billing month following the date of this Order, LG&E shall decrease its jurisdictional environmental revenue requirement by \$326,442 for one month.

3. All other provisions of the Commission's June 12, 2015 Order not in conflict with this Order shall remain in full force and effect.
