## <u>ORDER</u>

On April 8, 2015, Magoffin County Water District ("Magoffin County") tendered its application pursuant to 807 KAR 5:076 requesting to adjust its water rates through a phase-in plan. By this Order, the Commission approves a two-phase rate increase in retail water rates that will eventually generate \$294,895 in additional annual revenues, a 23.83 percent increase to pro forma present rate revenues of \$1,237,410.<sup>1</sup> Upon implementation of Phase I rates, the monthly water bill for a retail customer using 5,000 gallons of water will increase from \$34.85 to \$39.90, an increase of 14.5 percent. Upon implementation of Phase II rates, the monthly water bill for a retail customer using 5,000 gallons of water will increase from \$39.90 to \$43.14, an increase of 8.12 percent.

Commission Staff applied methods and practices that are generally accepted by the Commission to review the reasonableness of Magoffin County's pro forma financial statements, revenue requirement calculation, and requested retail water rates. On July 31, 2015, Commission Staff issued a report summarizing its findings. Commission Staff found that Magoffin County's proposed rates would generate additional revenues of

\$143,510 over pro forma test-year revenues.<sup>2</sup> It further found that, using the approach that the Commission has historically employed to determine a water district's revenue requirements, Magoffin County's financial condition would support a revenue increase of \$294,895.<sup>3</sup>

On August 7, 2015, Magoffin County advised the Commission of its acceptance of Commission Staff's findings regarding the need for a higher revenue requirement and of the rates that Commission Staff found would generate the higher revenue requirement. Magoffin County further waived its right to a hearing on its application and requested that the matter be submitted for decision based upon the existing record.<sup>4</sup>

On September 2, 2015, the Commission directed Magoffin County to publish in a newspaper of general circulation in its territory notice of the Commission Staff's determined rates and Magoffin County's request that those rates be approved. Magoffin County caused this notice to be published on September 10, 2015.<sup>5</sup> Accordingly, the Commission finds that good cause exists for the case to be submitted on the record.

Having considered the evidence and being otherwise sufficiently advised, the Commission finds that:

1. Magoffin County is a water district organized pursuant to KRS Chapter 74, and owns and operates facilities that distribute water to approximately 3,473 customers that reside in the Kentucky counties of Floyd and Magoffin. <sup>6</sup>

2. The calendar year ending December 31, 2013, should be used as the test period to determine the reasonableness of Magoffin County's existing and proposed water rates.

3. Based upon pro forma test-year operations, after adjusting for known and measurable changes, Magoffin County's pro forma present rate revenues and total pro forma operating expenses are \$1,289,611<sup>7</sup> and \$1,444,828,<sup>8</sup> respectively.

4. Magoffin County has one outstanding bond issuance that is payable to the Kentucky Rural Water Finance Corporation ("KRWFC"). The three-year average of principle and interest payment on this bond issuance is \$116,398.<sup>9</sup>

5. The Commission has historically used a Debt Service Coverage ("DSC") method to calculate the revenue requirement for water districts or associations with outstanding long-term debt.

6. Application of the Commission's DSC method to Magoffin County's pro forma operations results in a total revenue requirement from all sources of

\$1,584,506.<sup>10</sup> A revenue increase of \$294,895 from water service rates is necessary to generate the overall revenue requirement.<sup>11</sup>

7. Phase I rates calculated by Staff will not produce additional annual revenues of \$294,895; however, they will produce additional water revenues of \$179,424, which is sufficient to meet the DSC ratio requirements of Magoffin County's lenders.<sup>12</sup>

8. The record contains no evidence that permitting Magoffin County to assess Phase I rates will result in any degradation or reduction in the quality of service that Magoffin County currently provides.

9. A utility may assess rates that fail to produce a level of revenues that accepted ratemaking methodologies would regard as insufficient or inadequate. Absent evidence that the quality of the utility's service will decline or be degraded as a result of

this level of revenue, the rate phase-in plan proposed by Staff and agreed to by Magoffin County should be accepted.<sup>13</sup>

10. Phase II rates calculated by Staff will increase pro forma present rate water revenues by \$115,470.

11. Staff's phase-in plan evenly distributes the revenue increase to all Magoffin County's retail customers. An even distribution of the revenue increase to existing retail rates results in an equitable spread of the revenue increase to Magoffin County's customers and is appropriate, absent any evidence to the contrary.

IT IS THEREFORE ORDERED that:

1. The water rates requested by Magoffin County are denied.

 Staff's water rate phase-in plan, accepted by Magoffin County, is approved.

3. Magoffin County shall charge the rates that are set forth in Appendix A for service rendered on and after the date of this Order.

4. Magoffin County shall charge the rates that are set forth in Appendix B for service rendered effective the day after the first anniversary of the date of this Order.

5. No earlier than 30 days, but no later than 20 days prior to the first anniversary of the date of this Order, Magoffin County shall publish notice of the Phase II rates at least once in a newspaper of general circulation in its territory or place an insert in bills rendered to its customers. Notice shall be in the form set forth in Appendix C to this Order. Magoffin County shall file with the Commission proof of publication no later than ten days after publication of the notice.

6. Within 20 days of the date of this Order, Magoffin County shall file revised tariff sheets with the Commission, using the Commission's electronic Tariff Filing System, setting forth the rates approved herein.

7. Any documents filed pursuant to ordering paragraph 5 shall reference this case number and shall be retained in the utility's general correspondence file.

8. The Executive Director is delegated authority to grant reasonable extensions of time for the filing of any documents required by this Order upon Magoffin County's showing of good cause for such extension.

## NOTICE TO THE CUSTOMERS OF MAGOFFIN COUNTY WATER DISTRICT

On April 8, 2015, Magoffin County Water District ("Magoffin District") applied to the Kentucky Public Service Commission ("PSC") for authority to adjust its rates for water service. The initial proposed effective date of the requested rate adjustment was made pursuant to the date of an Order granting an increase by the PSC. After performing a review of Magoffin District's application and records, the PSC Staff has recommended to the PSC that Magoffin District adjust its rates to their retail customers that are different from those proposed by Magoffin District.
