ORDER

On September 28, 2015, Duke Energy Kentucky, Inc. ("Duke Energy") submitted an application to the Commission for a Certificate of Public Convenience and Necessity ("CPCN") to construct a gas pipeline from Walton, Kentucky, to Big Bone, Kentucky. A review of the application by Commission Staff revealed that it did not meet the minimum filing requirements set forth in 807 KAR 5:001, Section 15(2)(b) and KRS 322.340, and a notice of the filing deficiency was issued to Duke Energy on October 5, 2015.

On October 19, 2015, Duke Energy submitted to the Commission a notice of withdrawal of its application. Duke Energy states that it needs additional time to procure the documents necessary to proceed with its application and requests that this case be closed without prejudice. The Commission will treat Duke Energy's notice as a motion requesting Commission approval to withdraw its application.

Having reviewed this motion and being otherwise sufficiently advised, the Commission finds that Duke Energy's motion to voluntarily withdraw its application without prejudice should be granted.

IT IS THEREFORE ORDERED that:

1. Duke Energy's motion to withdraw its application is granted.

2. Duke Energy's application for a CPCN is dismissed without prejudice, and this case is closed and removed from the Commission's docket.
