ATTORNEY GENERAL'S  
MOTION FOR PROCEDURAL SCHEDULE

Comes now the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, and hereby moves the Public Service Commission to issue a procedural order in this matter and to afford the Attorney General and any other intervenors to this matter at least one (1) round of data requests to the applicant, Duke Energy Kentucky, Inc. ("DEK"). In support of his motion, the Attorney General states (1) that he was a stipulating and settling party to Commission Case No. 2014-00201, (2) that he wishes to tender a limited number of data requests to ensure a complete and thorough record and (3) that his data requests tendered simultaneously with this motion may be answered by DEK well in advance of the July 1, 2015, deadline by which time DEK desires a Commission Order.

WHEREFORE, the Attorney General requests that the Commission issue a procedural Order requiring DEK to respond to the Attorney General's limited single round of data requests tendered simultaneous with this motion.
