**APPLICATION FOR AMENDMENT AND EXTENSION OF AUTHORITY WITH  
RESPECT TO REVOLVING CREDIT**

Louisville Gas and Electric Company (“LG&E”) hereby requests that the Commission amend and extend LG&E’s existing authority to allow for extending the term of its multi-year revolving credit line. In support of this Application, LG&E states as follows:

1. LG&E’s full name is Louisville Gas and Electric Company. The post office address of LG&E is 220 West Main Street, Louisville, Kentucky 40202. LG&E was incorporated in Kentucky on July 2, 1913 and LG&E is currently in good standing.

2. LG&E was first granted authority to enter into multi-year revolving credit facilities in Case No. 2007-00232<sup>1</sup> by Orders dated August 2, 2007, and August 9, 2007. In Case No. 2007-00232, the Commission found that granting LG&E authority to enter into multi-year revolving credit facilities under which LG&E could incur short-term debt from time to time would reduce the time and cost of negotiating and renewing short-term debt arrangements.<sup>2</sup>
