- a. KIUC waives its right to service of any Commission Order by mail for purposes of this proceeding only.
- b. KIUC certifies that it or its agent possesses the facilities to receive electronic transmissions.
- c. Sets forth the electronic mail address to which all electronic notices and messages related to this proceeding should be served.
