**RE:** Informal Conference of November 30, 2015

An informal conference was held in these matters on November 30, 2015. A list of attendees is attached.

The purpose of the informal conference was to discuss the roll-in calculation for the environmental surcharge mechanisms of Kentucky Utilities Company and Louisville Gas and Electric Company (collectively the "Companies"). The Companies explained that their answers to requests for information and the testimony of Robert Conroy overstated the incremental roll-in amounts because the previously rolled in amounts were presented at net and not gross value. The Companies further explained that this did not affect the gross roll-in calculation, only the incremental amount.

Commission Staff asked clarifying questions regarding the billing mechanics of the roll-in amount, to which the Companies' representative stated that the previous roll-in amount is removed from base rates before the gross roll-in amount is used to calculate new rates. Commission Staff requested that the Companies provide a revised version of their responses to question 5 of Staff's initial data request and the testimony of Robert Conroy to show the corrected incremental amounts, which the Companies agreed to timely provide.

Finding that no party had any further questions, the conference was adjourned.
