### ORDER

On December 29, 2009, in Case No. 2009-00202,<sup>1</sup> the Commission approved rates for Duke Energy Kentucky, Inc. ("Duke") and provided for their further adjustment in accordance with Duke's Gas Cost Adjustment ("GCA") clause.

On August 9, 2016, Duke filed its GCA to be effective August 30, 2016.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Duke's notice includes rates designed to pass on to its customers its expected change in wholesale gas costs.
- Duke's Expected Gas Cost ("EGC") is \$4.065 per Mcf, which is an increase of \$.092 per Mcf from its previous EGC of \$3.973 per Mcf.
- Duke's notice sets out its current quarter Refund Adjustment ("RA") of \$.000 per Mcf. Duke's total RA is \$.000 per Mcf, which is no change from its previous total RA.

- 4. Duke's notice sets out its current quarter Actual Adjustment ("AA") of (\$.055) per Mcf. Duke's total AA is \$.388 per Mcf, which is an increase of \$.314 per Mcf from its previous total AA of \$.074 per Mcf.
- Duke's notice sets out its current quarter Balance Adjustment ("BA") of (\$.006) per Mcf. Duke's total BA is \$.078 per Mcf, which is an increase of \$.039 per Mcf.
   from its previous total BA of \$.039 per Mcf.
- Duke's GCA is \$4.531 per Mcf, which is an increase of \$.445 per Mcf from its previous GCA of \$4.086 per Mcf.
- 7. Duke's notice sets out a Gas Cost Adjustment Transition ("GCAT") Rider rate of \$.0466 per 100 cubic feet. This GCAT rate will be applicable to customers who begin receiving Rate FT-L transportation service after the effective date of this Order who paid gas supply costs through the GCA during the 12-month period before they began receiving FT-L service.
- 8. The rates as proposed by Duke and set forth in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Duke on and after August 30, 2016.

### IT IS THEREFORE ORDERED that:

- The rates proposed by Duke and set forth in the Appendix to this Order are approved for final meter readings on and after August 30, 2016.
- Within 20 days of the date of this Order, Duke shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.
